We expect further upside for **Mi Technovation** after it surged above the RM3.14 resistance and reached a 2.5-month high on Friday. With the 21-day and 50-day EMAs converging and likely to turn upward in the near term, bullish momentum is strengthening. A bullish bias may emerge above the **RM3.14** level, with a stop-loss set at **RM2.94**, below the 50-day EMA. On the upside, near-term resistance is seen at **RM3.50**, followed by **RM4.00**.
