Pentamaster Corporation may trend higher after posting another bullish candle and closing above the RM4.00 resistance yesterday. With the stock trading near its 52-week high and supported by its rising EMAs, the upward momentum is likely picking up. A bullish bias may emerge above the **RM4.20** level, with a stop-loss set at **RM3.96**, below the 6 May low. On the upside, near-term resistance is seen at **RM5.00**, followed by **RM5.50**.
