Cnergengz's buying interest is back after it broke out of a 3-week bullish flag pattern with a long bullish candle two sessions ago. With the stock pushing near its 52-week high and supported by its rising EMAs, this likely indicates that upward momentum is picking up. A bullish bias may emerge above the **RM0.52** level, with a stop-loss set at **RM0.46**, below the 21-day EMA. On the upside, near-term resistance is seen at **RM0.60**, followed by **RM0.65**.
