Kelington Group may rise further after testing the RM7.26 support and rebounding to near its all-time high two sessions ago. With the 21-day EMA remaining above the 50-day EMA since the bullish crossover in late April, the uptrend may persist in the near term. A bullish bias may emerge above the **RM7.70** level, with a stop-loss set at **RM7.24**, below the 21-day EMA. On the upside, near-term resistance is seen at **RM8.50**, followed by **RM9.00**.
