Coraza Integrated Technology may trend higher after it gapped up with a long bullish candle yesterday. The stock also surged to a fresh multi-year high, and together with its rising EMAs, this suggests that the bullish trend may persist in the near term. A bullish bias may emerge above the **RM1.07** level, with a stop-loss set at **RM0.99**, below the 21-day EMA. On the upside, near-term resistance is seen at **RM1.20**, followed by **RM1.30**.
