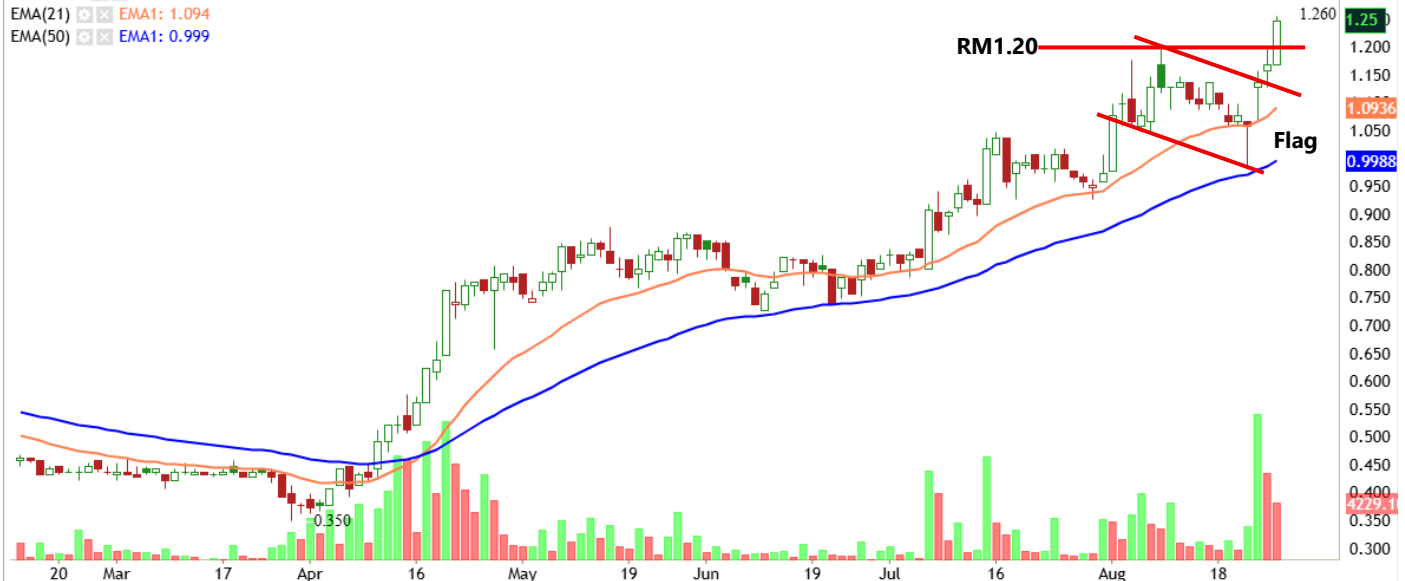

CPE Technology may trend higher after breaking above the RM1.20 resistance and hitting a new 52-week high yesterday. Given that the stock has also broken out of a 3-week bullish flag pattern, its previous uptrend may be resuming. A bullish bias may emerge above the **RM1.20** level, with a stop-loss set at **RM1.08**, below the 21-day EMA. On the upside, near-term resistance is seen at **RM1.40**, followed by **RM1.50**.
