GDB Holdings may trend higher after surging to a new 52-week high and closing above the RM0.38 resistance yesterday. With the 20-day EMA remaining above the 50-day EMA since the bullish crossover in mid-May, the uptrend may continue in the near term. A bullish bias may emerge above the **RM0.38** level, with a stop-loss set at **RM0.345**, below the 50-day EMA. On the upside, near-term resistance is seen at **RM0.44**, followed by **RM0.50**.
