Johor Plantations may trend higher after closing above the RM1.21 resistance with a long bullish candle yesterday. Given that the 20-day and 50-day EMAs are starting to turn upwards, additional upside strength may be seen in the near term. A bullish bias may emerge above the **RM1.21** level, with a stop-loss set at **RM1.12**, below the 7 May low. On the upside, near-term resistance is seen at **RM1.35**, followed by **RM1.40**.
