Steel Hawk may continue trending higher after surging to a new 52-week high and closing above the RM0.50 resistance a few sessions ago. With the 20-day EMA remaining above the 50-day EMA since the bullish crossover in late April, the uptrend may persist in the near term. A bullish bias may emerge above the **RM0.50** level, with a stop-loss set at **RM0.46**, below the 50-day EMA. On the upside, near-term resistance is seen at **RM0.57**, followed by **RM0.60**.

Entry : **RM0.50–0.515**Target : **RM0.57, RM0.60**

Exit : **RM0.46**
