MI TECHNOVATION (MI | 5286)



Mi Technovation may trend higher after surging to a new 52-week high and closing above the RM2.30 resistance two sessions ago. With the 21-day EMA holding above the 50-day EMA since the bullish crossover in late June, we believe the uptrend may persist in the near term. A bullish bias could emerge above the **RM2.30** level, with a stop-loss set at **RM2.18**, below the 21-day EMA. On the upside, near-term resistance is seen at **RM2.60**, followed by **RM2.70**.

Entry : **RM2.30–2.35**Target : **RM2.60**, **RM2.70**

Exit : **RM2.18**
