Farm Fresh's buying interest has returned after it broke out of a 2-week bullish rectangle pattern with a long bullish candle on Friday. As the stock also surged to a fresh multi-year high, coupled with its rising EMAs, a bullish outlook can be expected. A bullish bias could emerge above the **RM1.98** level, with a stop-loss set at **RM1.86**, below the 21-day EMA. On the upside, near-term resistance is seen at **RM2.20**, followed by **RM2.30**.

Entry : **RM1.98–2.02**Target : **RM2.20**, **RM2.30**

Exit : **RM1.86**
