UUE Holdings may trend higher after breaking above the RM0.80 resistance and hitting a 5-month high on Friday. With the 20-day EMA remaining above the 50-day EMA since the bullish crossover in late May, the uptrend may persist in the near term. A bullish bias may emerge above the **RM0.80** level, with a stop-loss set at **RM0.74**, below the 20-day EMA. On the upside, near-term resistance is seen at **RM0.93**, followed by **RM0.97**.

Entry : **RM0.80–0.815** Target : **RM0.93, RM0.97**

Exit : **RM0.74**
