Karex's buying interest has returned after it rose above its 20-day and 50-day EMAs yesterday. Given that the stock has broken above the downtrend line, its uptrend may continue in the near term. A bullish bias may emerge above the **RM0.80** level, with a stop-loss set at **RM0.74**, below the 50-day EMA. On the upside, near-term resistance is seen at **RM0.90**, followed by **RM0.95**.

Entry : **RM0.80–0.82**Target : **RM0.90, RM0.95**

Exit : **RM0.74**
