KJTS GROUP (KJTS | 0293) Last Price: RM1.07 | Technical Call: BUY



KJTS Group may trend higher after it broke above the RM1.05 resistance with a another positive candle on Friday. With its 20day and 50-day EMAs starting to trend higher again, additional upside strength may be present in the near term. A bullish bias may emerge above the **RM1.05** level, with a stop-loss set at **RM0.97**, below the 50-day EMA. On the upside, near-term resistance is seen at **RM1.15**, followed by **RM1.20**.

Entry : **RM1.05–1.07** Target : **RM1.15, RM1.20** Exit : **RM0.97**
