Alliance Bank Malaysia may trend higher after surging to a 3-month high and closing above the RM4.40 resistance yesterday. With the 20-day and 50-day EMAs now converging and likely to confirm a bullish crossover soon, additional upside strength may appear in the coming sessions. A bullish bias may emerge above the **RM4.40** level, with a stop-loss set at **RM4.13**, below the 4 Jun low. On the upside, near-term resistance is seen at **RM4.80**, followed by **RM5.00**.
