We expect further upside for **Inari Amertron** after it posted a long bullish candle and closed above the RM2.20 resistance a few sessions ago. With the 21-day and 50-day EMAs having formed a bullish crossover since mid-September, the stock appears positive in the near term. A bullish bias could emerge above the **RM2.20** level, with a stop-loss set at **RM2.05**, below the 50-day EMA. On the upside, near-term resistance is seen at **RM2.60**, followed by **RM2.80**.

Entry : **RM2.20–2.37**Target : **RM2.60**, **RM2.80**
