3 DEFINITION

- 3.1 For the purpose of these Conditions, the following words and expressions shall have the meanings assigned to them except where the context otherwise requires:

"Campaign" refers to the **"100% Brokerage Cashback Just For You"** campaign organised by the Bank in accordance with the Conditions as provided herein.

"Cashback" refers to the 100% brokerage cashback available in this Campaign.

"Bank" refers to AmInvestment Bank Berhad (company registration number: 197501002220 / 0023742-V).

"FIS" refers to the service provided by the Bank called 'Foreign Investing Services' which is made available to the Bank's clients holding a e-Direct Cash account and Collateralised Trading account.

"Prior Notice" refers to notices by the Bank to Eligible Participants within seven (7) calendar days and published on the Bank's website at www.amequities.com.my.

"SGX" refer to Singapore Exchange. Singapore Exchange is a Singapore-based exchange conglomerate, operating equity, fixed income, currency, and commodity markets.

4 CAMPAIGN PERIOD

- 4.1 This Campaign shall take effect from **17 May 2025 – 31 December 2025** (both dates inclusive) (**"Campaign Period"**). The Bank reserves the right to vary or amend the duration of the Campaign Period with Prior Notice.

5 ELIGIBILITY

- 3.1 The Campaign is open to new clients who open an eDirect Cash or a Collateralised Trading Account and fulfils the requirements of Clause 4 below during the Campaign Period (hereinafter referred to as **"Eligible Participants"**).
- 3.2 Permanent and contract employees, representatives and agents of the AmBank Group who are not allowed to participate in this Campaign.
- 3.3 The bank shall at all times have the discretion to determine the eligibility of the Eligible Participants for the Campaign.

- 4.2 The Eligible Participant shall execute trades via AmEquities during the Campaign Period on the stocks listed in the following exchange:-
 - 4.2.1 Bursa Malaysia Stock Exchange; and/ or
 - 4.2.2 Singapore Stock Exchange
- 4.3 The Eligible Participant MUST perform at least one (1) trade online or offline and generate a minimum brokerage fee of RM8 per trade during the Campaign Period. The Eligible Participant is required to pay brokerage fee at the time of trading.

5 CASHBACK REWARD

- 5.1 Upon satisfying the requirements stated in the Campaign Mechanics above, the Eligible Participants will receive Cashback capped at a maximum amount of RM100 per Eligible Participant during the Campaign Period.
- 5.2 Each Eligible Participant is entitled to receive the Cashback incentive ONE (1) time throughout the Campaign Period. - 7.11 All disputes concerning the construction, validity, enforcement and interpretation of the Conditions stipulated herein shall be governed by, construed, and enforced in accordance with the laws of Malaysia. The parties hereby submit to the exclusive jurisdiction of the Courts of Malaysia for the purpose of any suit, action or other proceedings arising out of Conditions herein.
