"**Prior Notice**" refers to notices by the Bank to Eligible Participants within seven (7) calendar days and published on the Bank's website at www.amequities.my

"**AmFutures**" refers to the Futures Broking Division of AmInvestment Bank Berhad (Company Registration Number: 197501002220 (0023742-V)).

2 CAMPAIGN PERIOD

2.1 This Campaign shall take effect from **1 July 2026 – 30 September 2026** (both dates inclusive). The Bank reserves the right to vary or amend the duration of the Campaign Period with Prior Notice.

3 ELIGIBILITY

3.1 The Campaign is open to all new and existing AmFutures individual clients with active futures trading accounts.

3.2 Corporate and institutional accounts are excluded from this Campaign.

- 3.3 Eligible Participants must maintain their trading accounts in good standing throughout the Campaign Period.
- 3.4 The bank shall at all times have the discretion to determine the eligibility of the Eligible Participants for the Campaign.

4 CAMPAIGN MECHANICS

- 4.1 Participation in the Campaign is automatic. All Eligible Participants who maintain an active AmInvestment Bank Futures Trading account and trade FKLM contracts during the Campaign Period shall be deemed to have accepted these Terms & Conditions and will automatically enrol to this Campaign.
- 4.2 Only trades executed in FKLM contracts during the Campaign Period shall be counted towards the participant's total trading volume.
- 4.3 Trading volume shall be calculated based on the total number of FKLM contracts traded (both buy and sell transactions) during the Campaign Period.
- 4.4 To qualify for any prize, a participant must execute a minimum cumulative trading volume of fifty (50) FKLM contracts (total buy and sell transactions) during the Campaign Period, either offline or online via AmEquities trading platform.
